Three Financial Projections for your Business classes were held with 16 attendees. 72 entrepreneurs attended Small Business Success Days in La Grande and Enterprise. 174 business owners received various types of technical assistance to access capital, receive one-on-one counseling, marketing, business planning assistance. NEOEDD offered Individual Development Accounts program and supported approximately 2818 individuals during the year.

They are therefore in the dual role of serving on the board and appointing individuals to the board of directors. The board also may appoint up to three individuals to the board.

NEOEDD prohibits board members or their families from applying for loan funds while active on the board and for two years following the conclusion of board service. The board members and staff are all aware of this restriction and staff would not process a loan application if the business was owned by a board member or former board member who met this criteria.

Form 990, Part VI, Section B, Line 15 - NEOEDDD hired the Local Government Personnel Institute to identify similar organizations in Oregon and establish comparable wages for all employees in the fall of 2017. The Executive Committee reviewed the salary survey and made a plan to increase salaries for nearly all staff as salaries were generally under the minimum amounts paid at other organizations. The salary survey is updated annually by increasing the comparable salaries by the increase in the Consumer Price Index. In the 2024/2025 fiscal year, the National Association of Development Organizations completed a comprehensive salary study that reported salaries nationwide and by organization size and region. These salary amounts were compared to the salary schedule used by NEOEDD. NEOEDD salary ranges were in the general range of comparable organizations.
